Election of Executive Committee & Office Bearers (2026–2028)

The Executive Committee of the **Association of Consulting Engineers Pakistan (ACEP)**, at its meeting held on **14 July 2026**, approved the Election Schedule for the election of the Executive Committee and Office Bearers for the term **2026–2028**.

Notes

- Considering that these are the first elections of the Association under the Trade Organizations Act, 2013 and the Trade Organizations Rules, 2013, the Executive Committee has, in the interest of transparency, orderly administration and facilitation of Members, provided reasonable administrative time at various stages of the Election Schedule to facilitate Members in understanding the election process, updating their Authorized Representatives, and enabling the Secretariat and the Election Commission to complete all necessary preparatory arrangements for the orderly, transparent and efficient conduct of the elections. Such additional administrative time does not prejudice the rights of any Member nor affect the statutory requirement to complete the election process within the prescribed time.
- Activities relating to objections, representations, appeals and decisions thereon shall apply only where such objections or appeals are filed.
- The last date for submission of requests for change of Authorized Representative has been fixed as 22 July 2026 to provide Members with three effective working days, considering 19 July 2026 (Sunday) as a weekly public holiday.
